Page 43 of Coffin's NEWBURY :-

"On Sept. 12, 1645, there was granted to William Ballard, 7 1/2 acres of land and 5 rods in the great field beyond the new line, called by name of the Divided Land,- to him and his heirs forever."

As the Lynn Ballard was dead, this surely was our ANDOVER man, and he was in Newbury before he came here.

At some date, yet unknown, William Ballard and his wife, Grace, were established on the Billerica Road. In 1661 he swapped with W. Chandler, and took a homestead, now the residence of Homer Foster. He died, July 10, 1689; Grace died April 27, 1694. In deposition of age, given in vol.7, page 148, he is 45 in 1662, so born about 1617. Possibly he was the young Ballard who tried to get here in 1633 but was sent back with others before they left the English Channel. He came first, I conclude, to Boston, and was free in 1638, at 21, when he was a member of the Artillery Co.

Vol. 2:page 247, Essex Records, shows William here in Andover and exchanging land with William Chandler, and sums of money to balance. He seems to take a house, barn, 4 acres, a hop-yard, bounds N and E by the land of Nathan Parker, W by land of John Lovejoy and Andrew Foster, (probably near present Library site) - the highway on the South ; all buildings mounds, fences belonging thereto. He gives a 5 acre house lot in Andover having Andrew Allen, N and W, the land of Wm. Chandler on the E; highway or common on the South, of which Wm. Chandler is now in possession.

Ipswich, Sept. 29, 1691:- Adm. granted to Joseph (2) Ballard on estate of father William (1), with William (2) and John (2), sureties. Inventory - 400 Lbs.

Each son is to have 50 Lbs.

Bedding, table linen, linen yarn, Necessary House, furnishings and implements, chests and boxes, small cupboard, barrels and other lumber, sider, man's clothes, neat cattle, sheep, mare, colt, swine, Indian corn and rye, iron work and a saddle- total -206 Lbs. 18sh. 6d. personal. (Thomas Chandler and John Abbott, committee.)

Articles concluded between Joseph, (2) John, (2) and William, (2) William (1) died without a will leaving the mother to be provided for. They agree to care for her and they decide what the sisters shall have:-

"Our honored mother, Grace, widow, to have liberty of dwelling in that house which was our father's, in which room she pleases, so long as she continueth his widow. Her bed and bedding and all other necessary house implements she needs, to be her own proper estate, for use during life- to be with clothes and what else she hath at her disposal as she hath cause at her death, amongst her children; 3 sons to be at equal charge to provide her two good cows, summer and winter- also lay her in every year, 16 weight good pork, 6 bush. Indian corn, 4 of Rye, 3 of Wheat, cord wood- each to give 20 sh. in money- 9 lbs. sheeps' wool, 12 lbs. flax from swingle."

The brothers were to divide the land and be of equal charge in care of mother and paying off the sisters.

Joseph, evidently the eldest, is to have 20 acres of Upland, "where his house is"; 50 acres of the Great Division; 14 acres by the Shawshin; 2 acres near James Frye; 6 1/2 acres of last division of meadow; 5 acres in Beaver Dam meadow; 1 1/2 acre in Redding meadow- (this was part of land allotted to old William when Lynn owned Reading) and which young John sold his share to Reading, later); 1/2 acre of pound meadow.

William (2) was to have 27 acres "where his house is"; 40 acres in Great Division tract in Shawshin fields; (this was the town bog, now our business center) 2 acres near James Frye (over on North Parish plain) 1/2 acre meadow on Shawshin.

John (2) was to have house lot and meadow his father lived on, except the land and meadow his father gave Wm. Blunt on his marriage with sister Elizabeth (2), which lies south of the land before named and is bounded out; John also has a division of land called the Island (more town bog); 1/2 the pound meadow, to which John is to have a way through Wm. Blunt's land; and to have half the Pond and Meadow with brothers, William and Joseph.

The sisters were to have 10 Lbs. apiece, -in addition to what they had already received- paid in something merchantable.

Widow Grace desires John Abbott to be her overseer and take care of her sons' yearly payments.

(William Blunt and Grace can only make their Xmark- but the sons-in-law, Butterfield, Henry Holt, and Jos. Wm. and John all write their names.

All the relatives appear and own this voluntary on their part- Sept. 28, 1691. Came to Haverhill to declare the same for the Court's confirmation, before Nath'l Saltonstall, assistant.

The children of William and Grace, were:-

Joseph (2), mentioned as eldest in article, page 1; m. Elizabeth Phelps, Feb. 28, 1665. She was daughter of Edward (2) Phelps and Eliz. Adams; a Newburg girl, who d. July 27, 1692. (see witch trials) Joseph's 2nd wife was Rebecca Rea, daughter of Joshua Rea and Sarah Waters, widow 1st of Samuel Stevens of Newbury and 2nd of Simon Orne of Marblehead, b. Sept. 4, 1656; d. Feb. 1, 1740; m. Joseph, Nov. 15, 1692. She joined So. Church 1712. Joseph died Sept. 29, 1722. He had a commission as Ensign, ^{1694-97-98,} the paper handed down in Jeremiah (3) line, and I have a duplicate. His homestead was site of Public Library. (Elizabeth Phelps is called Phillips in Court records, 11:54. It was often written so.)

1715:- Joseph Ballard, Sr., to Sam Phillips, my loving friend, I give absolutely a small tract, land laid out to my honored father, William, dec., -1 acre No. side parsonage house in South Precinct- NE cor. on house lot- line West by the way 26 p., then South 18 p., to white oak- marked by a great rock, - then East 10 p. to SS by wall - then by sd. wall to 1st bound. Note here that within sd. bounds a way is allowed 2 p. wide to remain forever, from the parsonage barn to the highway northerly. (Isn't this the avenue between Frank Kendall's and Batchelder's house?) The way to ye barn aforesaid he is not to have but all else is his.

Elizabeth (2), b . ;m. William Blunt of Charlestown, Nov. 11, 1668, in Chelmsford; Elizabeth d. July 11, 1689; he m. 2nd., Sarah-- ; he d. April 3, 1709, atv 67; the homestead was on street near cemetery and entrance to same.

William (2) , b. perhaps in Newbury; he m. April 20, 1682, Hannah Hooper of Reading, dau. of W. Hooper. William was in the Narragansett War and at Chelmsford garrison; he was here until 1713 when he sold the estate to the widow and son of Ben (2) Abbott, who added them to the other land they held.(I conclude the Abbott homestead was nearer Red Spring at first and changed to the site of Wm. Ballard's and the house was built about 1725, which is now standing. This was all the grant of Wm. Chandler once. The Foster farm, and across the river and down to Red Spring and Holts' Woods and Indian Ridge.Hartwell Abbott's heirs hold most of it.) William (2) Ballard was in Plainfield, Ct., by deeds, 1714; he died there. but I do not have date or age.

John (2), b. in ANDOVER, Jan. 15, 1653; m. Rebecca Hooper, sister to Hannah, above, Nov. 15, 1681; she was ^{sister also to} widow of Adam Hawkin , Sarah Hooper, -who m. ^{2nd.,} Samuel Wardwell and lived on what is now the Downing estate on Highland Road. Rebecca died Dec.1, 1715; an epidemic, possibly the grip, swept the family; and Ruth(3) was buried in the same grave with mother. Elizabeth (3) and Sarah (3) d. with parents; John d. Dec.18, 1715; he had served in Narragansett War. William (2) had moved away before this happened, and the homestead the Foster farm - of old William fell to John's share. The site was too damp.

1707; Recorded 1710:- William (2) Ballard sold to Capt. Jn. Barker, for 8 lbs. , 14 acre swamp, formerly joining John Ayer, Sr., now div. to each one's proper right; "my part I convey".(Wm. Chandler; Sam Ingalls, wits.)

Children of William (2) Ballard and wife, Grace, (cont.):

Sarah (2) b. in Lynn, July 15, 1654; (I have a theory that she and Joseph were children of a wife, Sarah, who preceded Grace.) m. Feb. 24, 1670, Henry (2) Holt, son of Nicholas (1) Holt and Elizabeth Short; she d. Nov. 23, 1733.

Hannah (2), b. Aug. 14, 1655; m. John Spalding of Chelmsford, Sept. 20, 1681; went to Plainfield, Ct.

Lydia (2), b. April 30, 1657; m. Joseph Butterfield of Chelmsford, May 12, 1674; (did she d. before 1691 ?)

Mary (2) ; m. Sam Butterfield before 1676; he was b. 1647; d. 1714.

Abigail (2), ; unm. in 1689; m. Sam(2) Wheat of Concord; m. 2nd., Boaz Brown of Concord and Dedham, whom she survived; made a will 1725; probate Sept. 5, 1726.

Joseph (2) Ballard (Wm. (1) and Elizabeth Phelps, had:

Joseph (3), b. Jan. 26, 1667; d. Sept. 1, 1732; m. Rebecca Johnson, Aug. 17, 1698, dau. Timothy(2) Johnson and Rebecca Aslebe, b. ab. 1672; d. Jan. 2, 1734; Joseph (3) was a husbandman; held estate near Library site. He may have built on division lands in so. part of town later.

Elizabeth (3), b. between 1667-70; (record lost) m. George (3) Abbott, Sept. 13, 1689; North Andover; son of Geo.(2) Abbott and w. Sarah ^Farnum; she d. 1706; age not given; he was a shoemaker; he m. 2nd., Hannah Estes, 1707, who d. 1741; he d. 1724. The ch. were all by Elizabeth, who named one, Uriah Abbott, for her brother, Uriah Ballard- a name seldom used outside the Ballard family.

Elinor (3), b. Aug. 24, 1672; m. John (3) Johnson, Sept. 13, 1689, son of Tom Johnson and Mary Holt.

Children of Joseph (2) Ballard and Elizabeth Phelps, (cont.):

William (3), b. Dec. 3, 1674; d. Sept. 2, 1707 ; prob. unm.

Hannah (3), b. Julu 11, 1677; fate unknown.

Dorothy (3), b. Nov. 8, 1679; m. Joseph Sibson of Portsmouth, before 1720; he a mariner; either he or a son bought the Joseph (2) Ballard place from Jeremiah (3) - the Library site.

Hezekiah (3), b. Mch. 22, 1682; d. Nov. 4, 1751; m. May 13, 1713, Rebecca (4) Davis of Billerica, daughter of Jos. Davis and -- Patten, b. Sept. 11, 1692, in Billerica; d. Jan. 22, 1752; he lived on a lot near his father's until he built over in the South part of the town, near the Manning place. In 1719, Joseph, his father, leaves to Hezekiah, blacksmith, " that part of my ancient homestead he is now settled upon- all that is left after his brother Joseph's share- Martin's Pond meadow; 6 acres of common rights to be shared with bro. Joseph, Uriah and Jeremiah- ; all meadow except the acre of meadow once thought to be in Andover but now proves to be in the bounds of Reading."

Uriah (3), b. Nov. 16, 1684; d. maybe in Wilton, N.H. after 1765; published to Elizabeth Mansur of Woburn, Oct. 15, 1712; she was b. July 30, 1678; d. June 22, 1741. 1719 Joseph (2) leaves to son Uriah, the meadow part of the Great Division he is settled on, "bounded between my land and that formerly brother William's- S by S. ls' thence to Thos. Blanchard-on small rocky hill- thence to dwelling house of Uriah; 1/2 River meadow I bought of Wm. Chandler".

Tabitha (3), b. March 19, 1687; d. March 30, 1687.

Tabitha (3), 2nd., b. Mch. 28, 1688; d. Feb. 24, 1691.

Sarah (3), b. Aug. 21, 1693; d. Jan. 3, 1716 by 2nd wife. Widow Ruth Orne (Rebecca?)

Humphrey (3), b. ab. 1695; 1st taxed here 1716; d. May 22, 1735; m. Nov. 6, 1717

Hannah Broughton of Windham; released rights in father's estate

Jeremiah (3), b. March 29, 1697; d. 1761; will probate Sept. 8; m. Dec. 29, 1721, Mary Dane, daughter of Francis Dane; sold to his brother-in law, Joseph Sibson, 1735 (69:116) his rights in the lands in Andover, for 1000 Lbs. - Homestead land nigh Meeting House north side highway (probably now School St.) on County Road- N.E. cor. of burying ground, line runs on road then goes to my house then by road to Deacon Wm. Lovejoy's (High St.) till you come to the road that goes to Eleazer Graves' house- then West along Graves' land to Shawshin River (probably down Harding, or a street this side of it)- over river, north to Deacon Wm. Lovejoy's land- W on his land to a gate; thence SW 1/2 rds. on Stephen Abbott's meadow- south all way on S. Abbott's land to Mill Pond- South side pond at Great Stone- (Wowards (Woods) E 50 rds. to land of Josia Ballard, my brother- to S.S- South to Ashtree NW cor. burying ground- along yard to NE cor.; house and barn; 1/4 grist mill, called Ballard's Mill, etc.-; land near Daniel Poor's house, once my father-in-law, Francis Dane's, I bought of Francis Faulkner; 10 acres I bought of Sam Astin; 20 or 30 acres laid out to father Joseph, etc. (Jn. Osgood; Dan Holt, sign.) Jeremiah (3) went to Lunenburg; was a Captain in French War, 1758; went to Concord, Mass and to New Salem.

Josiah (3), b. June 22, 1699; m. Mary Chandler, Aug. 7, 1721, b. March 28, 1702 daughter of Thos. (3) Chandler; he d. Dec. 26, 1780. From his Father, Joseph (2), in 1720, he got meadow and lands east side highway from So. Meeting House- north- between sd. road and the way to Capt. Abbott's meadow (Swift's cor. on Main St.) and Jos. Abbott's land and Abe Graves' land- with the barns on that side; another on same rd. and Deac. Abbott- (this pasture must be the Ballard pasture that included Elm Square by the way to Wm. Wardwell's and by Sam Preston's and Wm. Abbott's land; 3rd lot- all my land at Beaver Dam that son Jos. does not hold; 1/2 a pond meadow near Shawshin River; 1/2 of corn mill called Ballard's Mill — — — — —

Children of Joseph (2) Ballard and 2nd wife Ruth Orne (cont.):

1/2 of land falling to me, granted by town to encourage the setting up of the same (corn mill) and maintaining said mill, lying between the Shawshin River and Capt. Abbott's lott; all land described lies in Andover, except Beaver Dam meadow and upland bordering, which are in Billerica; also 1/2 my 100 acre lot in East part of Windham, Ct., 1/2 the stock, leaving out brother 'eremiah's horse; the house; 1/2 the tools. (Sam Phillips and Tom Chandler, sign.)

Jeremiah (3) received from his father Joseph (2), 1720:-

" Homestead-

no. side highway all land between South Meeting House - and way from my house towards Abraham Graves- and between road and way from Graves down towards Ballard's Mill to the gate- thence to Meeting House- dwelling house on County Road- 1 parcel land between rd. to A. Graves and rd. to Deacon Lovejoy's (was Abraham Graves down by Major Lowe's place, bought by Ben Ames?) (old Sally Holt's house-rd. later extending to Andover Bridge) - all interest in land laid out to me near Billerica line-beyond Thos. Hagggett's house- 1/2 river meadow E. end in Billerica - 1/2 Pond meadow near Shawshin- 1/4 part of cornmill called Ballard's- 1/2 land granted by town for setting it up, as above- land north part of Shawshin bds. by River and Mill aforesaid- on each side rd. from Bridge towards Stephen Abbott's house he bought of John Russe (that is when Johⁿ Russe lived in Abbott Village near river)- all except river meadow- a share in commons not laid out- if there prove to be any division- equal shares with sons: Joseph, Hezekiah and Uria- also 1/2 the 100 acres in Windham, Ct., -and his horse, commonly called his; One half stock leaving out Josia's horse; 1/2 tools and tackle, buildings, etc." Sam Phillips and Thomas Chandler, witnesses)

40:173- David Abbott sold to Hezekiah (3) Ballard, 1722, 1 1/2 acre of land and 1/2 of 2nd part of 3rd Division of Commons, near Martin's Pond meadow, belonging to said Hezekiah.

(Joseph Wright; James Stevens, witnesses)

Notes:- 3:45- When William Young of Andover, was sentenced to the whipping post for wishing somebody to be hanged, -which occasioned the order for whipping- William⁽¹⁾ Ballard and Andrew Allen testify, and I believe Sarah Barrier, also the widow of Frances Hazeltine of Wenham- all of Andover. March 1656.

3:85- Wm. Ballard⁽¹⁾ and Robert Barnard, are witnesses in a case of Edmund Bridges of Andover, for lying about 100 rails for Shawshin Bridge- when he had only 23. Hon. Simon Bradstreet is a witness. Edmond said that he had brought a letter from his father to his master, but he had none. Sept. 1656.

1658 Wm.⁽¹⁾ Ballard on choice of Sgt. John Osgood.

7:145:- Chandler and Tyler case. Wm.⁽¹⁾ Ballard age about 45, deposes. Also deposes in case of Godfrey vs. Tyler-ox and cow scrape. 1662.

WITCHCRAFT in Andover. See page 154- History of Andover, by Abiel Abbot.

Elizabeth Phelps, wife of Joseph Ballard, fell ill, and on the advice of some of the townsfolk, he was persuaded to send to Salem Village where, it was said, there were girls who could tell the names of those persons who were able to afflict others. Thinking he could discover the cause of Elizabeth's sickness, he asked two of the hysterical girls to attend a meeting held at North Meeting House, in North Parish.

As these girls were supposed to have been afflicted by witches, it was believed that they would be able to discover the person or persons afflicting Goody Ballard, since the presence or touch of a "witch" would send them into spasms.

Various women of the parish were summoned to the Meeting-house and were blindfolded. Mr. Barnard, pastor, next held a prayer service, & the goodies laid hands on the so-called afflicted-girl visitors. The fits followed. All the women were seized and thrown into prison. The examination of Goody, Ann Foster, in July 1692, accused of practising witchcraft on Dame Elizabeth Ballard, was the beginning of the tragedies in Andover.

Elizabeth Ballard died July 27, 1692.

Sherebiah (3), b. Nov. 14, 1688; m. Lydia Osgood, Jan. 2, 1717; he sold the estate of Ballard to Capt. John Foster of West Andover, who also m. an Osgood; d. probably in Willington, Conn.

Ruth (3), b. Feb. 15, 1694; d. Dec. 2, 1715; buried with mother.

Sarah (3), b. May 6, 1696; d. Nov. 27, 1715

Elizabeth (3), b. June 29, 1699; d. Dec. 9, 1715 (bad drainage near river / swamp.)

John (2) made his will on Nov. 30, 1715, making provision for Rebecca, who died the next day- Dec. 1. Daughter Sarah had died three days previously Nov. 27, and John was very sick. Ruth died and was buried with her mother, Elizabeth died just a week later. Notice is given on our Town Record: "John Ballard, ye husband of Rebecca and father of ye above daughters, dyed Dec. 18, 1715, about 62.-So the poor constable, who 23 years before had marched Martha Carrier(accused of witchcraft) off to her death, went with his band of four, leaving daughter Rebecca and her two brothers to sit alone.

No wonder they did not care to stay here. Sherbiah held the home lands of old William (1) Ballard, so whoever he sold to, had them. Jonathan moved to Billerica property left him by his father(" all lands and buildings and meadows in Billerica, N. England; a pair of pistols and holsters; my carbines 1/3 of personals and what he needs of this year's crop for subsistence", was his share of John(2)'s estate)- brother Sherebiah was heir to "real estate and common rights in Andover; 2 parts of personals, tackle, goods, loom and tackle".

March 1829- they sold the cows, horse-shed, scraper- 4 doz. bottle etc., and raised \$6,810.08 , on personal estate. Bills came in to add.

Timothy (6) Ballard was very small and active. He broke his hip a few years before he died, and went insane near the end. Mrs. Gould says that he was born in the Manning house- that is wrong, it was his father, Tim(5) who was born there. His uncle, Joseph (5) got the place by inheritance. Tim(5) built a home back of the Manning place, which, all agree, was built by old Deacon Hezekiah, who m. Lydia Chandler, and it was originally a part of the old Chandler grant.

Tim (5) built later near the Mill in the Vale, and this Tim(6) inherited. It stood on the west side of the river, and he owned also a great deal of land on the east side- all of which went to son Tim.

Tim owned 1,000 cows, according to Mrs. Gould, and he used to let them out to people, to be returned to him when the calf was 3 years old.

She also tells that he was very prompt about getting to the mill on time in the morning, and often ate his bread and milk on the way, leaving the bowl and spoon on the stone wall, to be picked up and brought back to his house. He often forgot them and where he had left them. When the walls were being torn down to build up the village, Tim's spoons were found in them.

When Tim's horses were cold and wet, he used to bring them into the kitchen to get warm.

Davied Mears of the Vale told Poor that Tim's father owned the Vale before he died. He said too, that Tim's wife, Mary Foster, used to tend bar, when they kept a tavern in B'vale for a while.

When the estate was sold, widow Mary got \$2.200 for the homestead, from Herman P. Chandler. Mrs. Mann bought it in 1843 and held it until 1847. Then she sold to Marland, and what they didn't want, the B.&M. R.R. got.

" Stephen Ballard, son of

Joshua (6) Ballard and Phebe Abbott, was born in Andover, Sept. 9, 1818, in the old house--last occupied by Capt. Allen-- the famous ancient Ballard Tavern of the Revolution.

He was educated in our schools here-- probably at Phillips Academy, he trained early in John Marland's Mills at Ballardvale, in the making of delains, the first made in this country. Later, with his brothers Gayton and Joshua, he removed to Korkset, N.H., where they changed the cotton mills to delain mills. At Southbridge, Mass., the brothers later established factories for cotton and woolen goods-- the Hamilton Mills,-- controlled by them.

Stephen became a manufacturer also of leather belts and rubber belting and of late years invested successfully in cabinet works, picture frames and other pine wood work. He was especially versatile, being an all round mechanic and business manager.

He married, Dec. 24, 1840. Sarah Ballard Russell, a distant cousin, daughter of Abiel Russell and Sarah Abbott, but she died in Oct. 2, 1851, childless. He married second, Abby Dodge, Nov. 18, 1852. She died June 8, 1895.

Neither Stephen nor Nathan left children. Gayton was 80, and a grandson, Gayton Ballard Ellis, are all that are left of a long line of Ballard ancestry-- pioneers of Andover, who left their name on old landmarks."
